CANWEL BUILDING MATERIALS ANNOUNCES FIRST QUARTER 2017 FINANCIAL RESULTS

Q1 2017 Financial Highlights⁽¹⁾:

- Revenues increased 12.8% to \$223 million
- Gross Margin dollars increased 16.4% to \$27.0 million or 12.1% of revenues
- EBITDA⁽²⁾ increased 51.5% to a first guarter record \$8.2 million

VANCOUVER, **CANADA** – May 9, 2017 – CanWel Building Materials Group Ltd. ("CanWel" or "the Company") (TSX:CWX) announced today its first quarter 2017 financial results⁽¹⁾ for the period ended March 31, 2017.

For the three month period ended March 31, 2017⁽¹⁾, consolidated revenues increased by 12.8% to \$223 million when compared to \$198 million in the same period in 2016. Sales in the Building Materials Distribution segment comprised approximately 38% of this increase, largely due to the Company's continuing focus on its product mix strategies and target customer base, as well as the results from the TFI acquisition. The majority of the sales increase however was attributable to the Company's new Forestry segment, notwithstanding that such sales were impacted by continued adverse wet weather conditions across British Columbia and Saskatchewan. These adverse weather conditions continued to negatively impact the Forestry segment through the first several weeks of the first quarter of 2017, although once these conditions abated in the latter part of the first quarter, the Forestry operations returned to full productivity.

Gross margin dollars increased by 16.4% to \$27.0 million, compared to \$23.2 million during the corresponding period in 2016. Gross margin percentage also increased to 12.1% of revenues versus 11.7% during the same period in 2016. The increase in gross margin percentage margin percentage and dollars is mainly due to the results from the Company's 2016 acquisitions and a change in the Company's sales mix within general categories of construction materials and specialty and allied products.

EBITDA⁽²⁾ increased to \$8.2 million, a record for the Company's first quarter, representing a 51.5% increase in EBITDA when compared to the first quarter of 2016. As a result, Net Earnings⁽³⁾ increased by 82.9% to \$1.7 million, when compared to \$912,000 during the corresponding period in 2016.

"Despite the impact of the adverse weather conditions on our forestry operations, I am pleased with the overall strength of our business model with margin growth outpacing top line growth during one of our slow seasonal quarters," commented Amar S. Doman, Chairman of the Board. "Our hard work across the Company resulted in a record EBITDA for our first quarter. We have continued our focus on execution as we entered the second quarter. Both of our business segments are returning to results in-line with our expectations. Additionally, I would note that the recently announced Softwood Lumber duties are generally a non-event for CanWel, as we rarely ship softwood lumber into the United States."
