PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Causes eye irritation. DO NOT get in eyes. May irritate skin. Avoid contact with skin. It is recommended to wear rubber gloves and goggles when handling this product. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms and non-target terrestrial plants.

Cut-N-Seal[®] Wood Preservative is for cuts, holes and injuries to pressure treated wood used in above ground applications. Cut-N-Seal Wood Preservative is not to be used in preserved wood foundations, to recoat pressure treated wood surfaces, or as a replacement for pressure treatment.

DIRECTIONS FOR USE: For above ground exterior use only. Not for use in dwellings. Apply by brush only at a temperature above 10°C (50°F). Do not spray or dip. Ready to use – do not dilute. Wood should be dry and clean. Shake or stir contents before and periodically during use. Apply a first coat by brush to thoroughly cover the exposed area. Allow product to absorb and apply a second coat. Once second coat is dry to the touch, wood is ready for installation. DO NOT apply to any body of water. DO NOT apply this product to wood that will be used in water.

CLEANUP: Clean equipment (brushes, etc.) with soap and water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

STORAGE: Store this product away from food or feed. Keep container tightly closed when not in use. **Keep from freezing.**

DISPOSAL: DO NOT reuse the empty containers. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.
